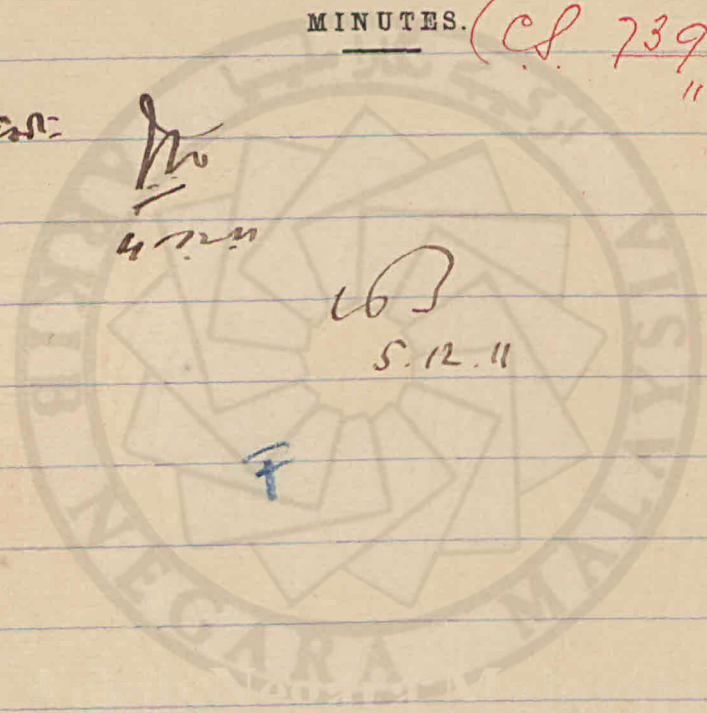

MINUTES OF THE MEETING HELD ON TUESDAY, 14<sup>TH</sup> NOVEMBER, 1911,

AT 10 A.M.

1. On the motion of the PRESIDENT the minutes of the meeting held on the 13th November, 1911, which have been circulated to the members, are confirmed.

2. The Council goes into Committee and resumes consideration of "The Registration of Titles Enactment, 1911."

The Bill is amended as follows:

In Clause 27, lines 4 and 11, after the word "Enactment," the figures 1911 are inserted.

In Clauses 29, 36 and 43, after the word "proprietor" in line 2, the following words are inserted: "or if such proprietor is a minor or of unsound mind the guardian, next friend or other person appointed by the Court to act on behalf of the minor or person of unsound mind in the matter."

In Clause 36, line 8, after the word "consented" the words "in writing" are inserted.

In Clause 50, line 5, after the word "Enactment" the figures 1911 are inserted.

In Clause 58, line 1, after the word "land" the following words are inserted: "if not a minor, a lunatic or a person of unsound mind."

In Clause 70, sub-clause (i), line 4, after the word "land" the following words are inserted: "or if such proprietor is a minor or of unsound mind the guardian, next friend or other person appointed by the Court to act on behalf of the minor or person of unsound mind in the matter."

In Clause 71, sub-clause (i), the words "every signature" are substituted for the words "The signature of every party."

The Bill having been settled in Committee the question is put "that this Bill be reported to the Council with amendments."

The Council resumes, and the CHIEF SECRETARY reports the Bill to the Council.

The PRESIDENT puts the question "that the Bill do pass."

The Bill is passed.
